- This amendment modifies, adds or deletes projects funded from the State Transportation Improvement Program, Road Repair and Accountability Act of 2017, and various Federal Transit Administration (FTA) programs.

MTC has certified that the amendment is financially constrained, does not change air quality conformity, and meets the requirements of public involvement procedures adopted by MTC.
