

## Plan Bay Area 2040 and 2019 Transportation Improvement Program Amendments

#### Interstate 680 Express Lanes Gap Closure Project (Alameda County)

The Metropolitan Transportation Commission (MTC) has released for a 30-day public review and comment period draft amendments to Plan Bay Area 2040 and the 2019 Transportation Improvement Program (TIP), along with a Draft Transportation-Air Quality Conformity Analysis.

The draft amendments seek to add the scope and cost of the Interstate 680 Express Lanes Gap Closure Project (Alameda County) into Plan Bay Area 2040 – the region’s integrated long-range land use and transportation plan prepared by MTC and the Association of Bay Area Governments (ABAG) – and the federally-required Transportation Improvement Program – a comprehensive listing of Bay Area surface transportation projects that are to receive federal funding or are subject to a federally required action, or are considered regionally significant for transportation-air quality conformity purposes.

#### The 30-day Public Comment Period Begins on March 26, 2020!
